Investment update - June

During June, market valuations remained elevated even with a backdrop of confused economic, political and market data. With monetary policy's effectiveness now largely extinguished, and positive market surprises becoming less prevalent, economic growth levels remain suppressed at modest levels. With the stall of the US 'reflation trade', Europe has picked up the baton on economic momentum on the back of low interest rates and continuing quantitative easing. With a falling oil price and escalating debt concerns in China, markets were drawing some comfort from ongoing M&A activity boosted by cheap sterling assets and cheap debt. With such a widespread list of global event risks, no changes were made to the Adventurous strategy's positioning. Equity market exposure remained anchored at the 80% bottom end of the strategy's strategic range with a range of fixed interest and alternative investments providing the balance of the strategy's underlying holdings. Our investment committee remains convinced that a considered and cautious approach will pay dividends during expected bouts of market weakness.






