Investment update - October

Following our latest Investment Committee meeting, changes were made to the Balanced strategy during October's quarterly rebalance. The Henderson Index Linked Bond fund was sold, with some proceeds being reinvested into the Threadneedle Sterling Short Dated Corporate Bond fund, with the balance being retained as cash. The Henderson fund disposal represents a continuation of our current policy to reduce longer duration UK index-linked bond exposure to minimise duration risk within our strategies. Our Investment Committee felt that it was still too soon to be increasing equity risk, which continues to target a 40% weighting within the Balanced strategy, given we are about to enter unchartered waters; the replacement of a decade's worth of crisis monetary policies is likely to be quite troublesome. A change was made to the underlying UK equity income asset allocation, with the Henderson UK Equity Income & Growth fund being sold and proceeds being invested into the newly added Franklin UK Equity Income fund, to increase exposure to international earnings within the UK fund allocation.

Investment objective

Our strategies are constructed around five investment strategies, each with a differing commitment to equities via collective funds and other asset classes. The strategy is managed with a maximum target of 60% invested in equity markets at any given time and has been categorised as a Bordier UK risk score:






