#### Investment update - December

No changes were made to the underlying investments during the month of December meaning the Adventurous strategy ended the year as it started; with a 80% equity target. Despite our considered approach to global markets throughout 2017, we are mindful that economic growth has improved across the board with continued stimulus from low interest rates and asset buying programmes supporting the upturn in growth. Our Investment Committee's consensus that now does not seem the right time for excess risk-taking remains firm, however it is acknowledged that some economic headwinds have dissipated sufficiently to a level where perhaps a moderate (and well overdue) market setback could create an opportunity to tilt the strategy's risk exposure back towards a neutral position. Whilst we await a window of opportunity from a sufficient market correction, we continue to assess positions within the alternatives sector with a view to move away from any investments that are more likely to suffer to keep pace with a rising inflationary environment. Any changes will be outlined in following factsheets.

The service offers five investment growth strategies ranging from Defensive to Adventurous and is available on the following platforms; Ascentric, Aviva, FundsNetwork, Fusion, Novia, Nucleus, Praemium, Seven Investment Management, Standard Life, Transact and Zurich.

#### Investment objective

The objective is to build capital in real (inflation-adjusted) terms over the medium to longer term. Investors should expect a high correlation to stockmarket behaviour and rewards, and be entirely comfortable with substantial volatility and very limited protection in times of market weakness.

#### Risk score

Our strategies are constructed around five investment strategies, each with a differing commitment to equities via collective funds and other asset classes. The strategy is managed with a maximum target of 100% invested in equity markets at any given time and has been categorised as a Bordier UK risk score:

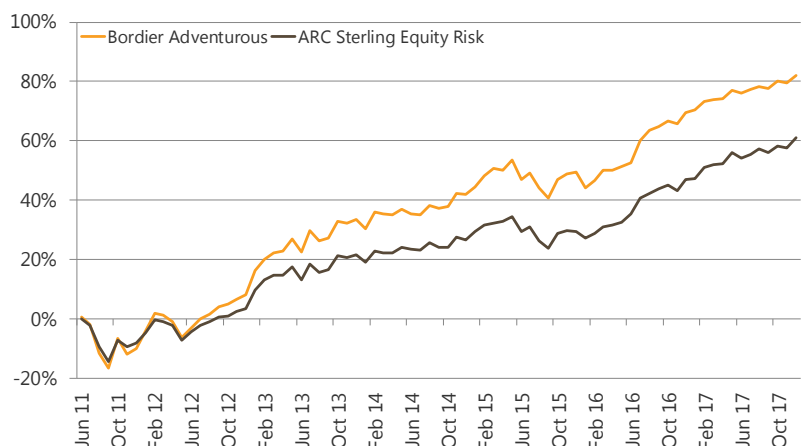

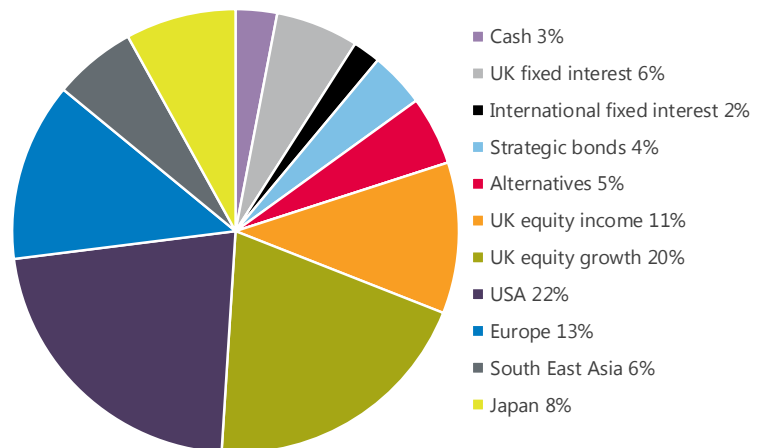

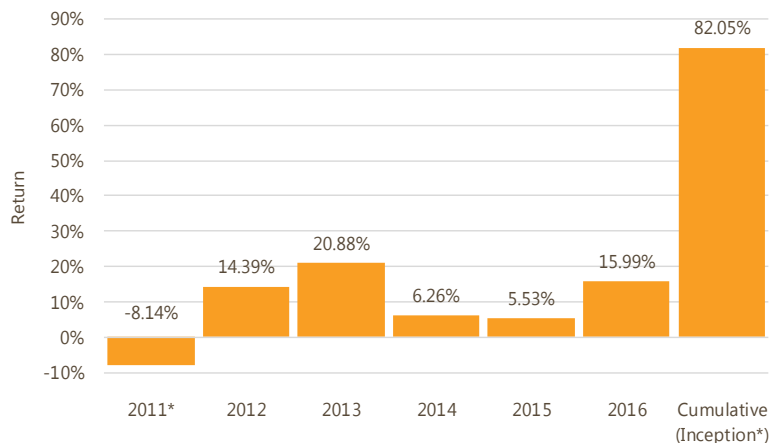
